### **RESEARCH AND TEACHING**

Fabiola Massa is Assistant Professor at “Tor Vergata” University, Department of Management and Law, where she teaches in the field of intellectual property and innovation, with particularly attention to biotech and pharmaceutical topics.

She's one of the Scientific Committee members of the reviews “Nuovo diritto civile” and “I Battelli del Reno”. She has taken part, for seven years, as member of editorial staff, to the works of “Treccani Legal Encyclopedia”, for which she wrote and published the pages on Biotechnology Inventions, Plant Varieties, Industrial Design and Unfair business-to-consumer Commercial Practices.

Dr. Massa served as Master teacher on IPRs at several courses present in her university and in other institutions. Her studies has been published in law journals and books concerning IPRs.

Since March 1<sup>st</sup>, 2018 Dr. Massa is Principal Investigator of the Research Project “SustainCO - Sustainability measures at Company level: a national survey for better implementation” supported by “Tor Vergata” University with a duration of 18 months.

Furthermore she's also one of the members of research staff in the Project known with the acronym “OLTRE” (Oltre l'orizzonte. Contro narrazioni dai margini al centro: Impact evaluation research about actions) funded by the European Commission for a period 14 November 2018 - 14 November 2020 (Proposal No. 812584).

In September 2008, Dr. Massa visited the Canadian Universities: Mc Gill and Sherbrooke, thanks to a fellowship of the International Council for Canadian Studies, during her stay she carried out a research on the technology transfer system put in place by the Canadian universities.

Since 2017, Dr. Massa is member of the Scientific Council of the Center for Studies and Research on Economic Intelligence and Security Management of “Tor Vergata” University and Steering Committee member of the Italian Academy of the Internet Code.

Since May 2014, she's member of Joint Committee established by the Conference of Italian University Deans (CRUI), the collecting society SIAE, the Authors and the Publishers, with the duty to manage a fund fed by taxes on photocopies made inside the university libraries.

Since 2011, Dr. Massa is member of the Italian group of ALAI (International Literary and Artistic Association) founded in 1878 by the great French writer Victor Hugo.
